MS&AD Insurance Group Holdings, Inc. (hereafter referred to as "we") is pleased to announce that at the Board of Directors meeting held on March 28, 2025, it was decided to proceed with specific discussions and preparations for the merger of two core non-life insurance companies within the group, Mitsui Sumitomo Insurance Co., Ltd. (President:Shinichiro Funabiki, hereafter "Mitsui Sumitomo Insurance") and Aioi Nissay Dowa Insurance Co., Ltd. (President:Keisuke Niiro, hereafter "Aioi Nissay Dowa Insurance"). The target date for this merger is set for April 2027.

Our group has the vision* of "Creating a world-leading insurance and financial group". To achieve this vision and support the development of a resilient and sustainable economy and society, we will proceed with discussions and preparations to merge Mitsui Sumitomo Insurance and Aioi Nissay Dowa Insurance to build a more robust domestic non-life insurance business structure. Additionally, in response to various issues such as price-fixing and information leakage incidents, we plan to enhance the compliance system. With shareholder approval at the Annual General Meeting, we intend to transition to a company with an audit and supervisory committee and change the majority of Director to outside Director, thereby strengthening the supervisory and check-and-balance functions of the Board of Directors. This will eable us to effectively monitor the internal control systems of group companies.

This merger will establish a non-life insurance company that holds the top market share in the domestic nonlife insurance sector.
